1 I, MARGARET L. SATTERTHWAITE, under penalty of perjury, declare as follows,  
2  
3 pursuant to 28 U.S.C. § 1746:

- 4 1. I am a licensed attorney and co-director of the International Human Rights Clinic at New  
5 York University School of Law. The International Human Rights Clinic is part of  
6 Washington Square Legal Services, Inc. ("WSLS"). WSLS was retained by Plaintiff  
7 Mohamed Farag Ahmad Bashmilah ("Mr. Bashmilah") in 2006 and I represent him as co-  
8 counsel in this action.
- 9 2. I submit this declaration in support of Plaintiffs' Opposition to the United States' Motion  
10 to Dismiss or, in the alternative, for Summary Judgment. Specifically, I submit this  
11 declaration to demonstrate the significant number of documents in the public domain  
12 regarding the apprehension, rendition and detention of Mr. Bashmilah as part of the  
13 Central Intelligence Agency's ("CIA") rendition program. These documents comprise,  
14 *inter alia*, reports published by non-governmental organizations concerning Mr.  
15 Bashmilah's case; documents published by inter-governmental bodies expressing concern  
16 about Mr. Bashmilah's treatment; and media reports concerning the rendition and  
17 detention of Mr. Bashmilah. This declaration does not discuss all of the documentation  
18 that has been made public concerning Mr. Bashmilah's experience. Instead, it gives a  
19 sense of the breadth and scope of the facts that are readily available in the public domain.  
20 With one exception, all of the documents cited here were published in English. I am  
21 aware that media outlets which publish in other languages, including Arabic, French, and  
22 Spanish, have published stories concerning Mr. Bashmilah as well.
- 23 3. Amnesty International ("AI") conducted several missions to Yemen in 2005 and 2006, in  
24 part to investigate the rendition and secret detention of Mr. Bashmilah. These missions  
25 resulted in a series of detailed reports that recount Mr. Bashmilah's experience within the  
26  
27

1 CIA rendition program. On August 4, 2005, while Mr. Bashmilah was still in detention in  
2 Yemen following his release from U.S. custody, AI issued a report documenting his  
3 experience in the CIA rendition program. Attached hereto as Exhibit A is a true and  
4 correct copy of Amnesty International, *USA/Jordan/Yemen: Torture and Secret*  
5 *Detention: Testimony of the "Disappeared" in the "War on Terror"* (Aug. 4, 2005),

7

4 9. On June 12, 2006, the Parliamentary Assembly Committee on Legal Affairs and Human  
5 Rights of the Council of Europe published a report on the U.S program of extraordinary  
6 rendition. This report followed an investigation conducted during a period of several  
7 months by Committee Rapporteur Dick Marty that examined the complicity of European  
8 nations in the CIA rendition program. This report documented Mr. Bashmilah's  
9 experience and reported Amnesty International's belief that he was held "somewhere in  
10 eastern Europe" before being returned to Yemen on May 5, 2005 following a seven hour  
11 flight. Council of Europe Parliamentary Assembly Committee on Legal Affairs and  
12 Human Rights (Rapporteur Dick Marty), *Alleged Secret Detentions and Unlawful Inter-*

3 11. On October 21, 2007, the leading Danish newspaper, *Politiken*, reported that the  
4           Gulfstream jet registered as N379P crossed Danish airspace before collecting Mr.  
5           Bashmilah from Amman, Jordan and transferring him to Kabul, Afghanistan. The report  
6           details Mr. Bashmilah's experience in the CIA's extraordinary rendition program.

13. The United Nations (“U.N.”) has on a number of occasions publicly expressed concern about the treatment that Mr. Bashmilah suffered as part of the U.S. rendition program. Several U.N. entities have issued public reports or opinions referencing concern about Mr. Bashmilah’s treatment and have engaged in correspondence with the governments involved in Mr. Bashmilah’s apprehension, rendition, and detention. These reports and correspondence make publicly available key facts concerning Mr. Bashmilah’s experience. Attached hereto as Exhibits M through S are true and correct copies of relevant excerpts from the U.N. documents summarized below.

14. The U.N. Special Rapporteur on the Promotion and Protection of Human Rights and Fundamental Freedoms while Countering Terrorism, Professor Martin Scheinin, together with the U.N. Special Rapporteur on Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, Professor Manfred Nowak, communicated with several countries concerning Mr. Bashmilah, relaying the facts regarding abuses that he suffered during his rendition and secret detention and requesting an official response. On December 23, 2005, Special Rapporteur Scheinin submitted a report to the United Nations Commission on Human Rights detailing these communications. Attached hereto as Exhibit M is a true and

1 correct copy of relevant excerpts from the Report of the Special Rapporteur on the  
2 Promotion and Protection of Human Rights and Fundamental Freedoms while Countering  
3 Terrorism, Addendum, Communications with Governments (2005). The report documents  
4 the following joint communications from Special Rapporteur Scheinin and Special  
5 Rapporteur Nowak to the governments of Indonesia, Jordan, the United States, and Yemen:  
6

- 7 i. **Indonesia** - On November 18, 2005, in a letter to the government of Indonesia, the  
8 two Special Rapporteurs posed “specific questions concerning the legal basis for  
9 the detention procedures to ensure that [Mohamed Bashmilah and another  
10 detainee] had recourse to judicial review of the lawfulness of their detention and  
11 the applicable legal basis for measures referring to ‘terrorism’.” The Special  
12 Rapporteurs requested a response by January 14, 2006. *Id.* at paras. 3-4.  
13
- 14 ii. **Jordan** - On November 17, 2005, in a letter to the government of Jordan, the two  
15 Special Rapporteurs drew the government’s attention to information they received  
16 alleging that Mohamed Bashmilah had been tortured by officials in Jordan. The  
17 Special Rapporteurs posed “specific questions concerning the legislation in Jordan,  
18 e.g. on the legal basis for the detention procedures to ensure that detainees have  
19 recourse to judicial review of the lawfulness of their detention, and the applicable  
20 legal basis for measures referring to ‘terrorism,’” and requested a response by  
21 January 14, 2006. *Id.* at paras. 5-8.  
22
- 23 iii. **United States** - On November 17, 2005, the two Special Rapporteurs asked the  
24 U.S. government to respond to specific allegations concerning Mr. Bashmilah’s  
25 experience in U.S. custody, calling to the attention of the U.S. government  
26 allegations that he had been held incommunicado for an extended period in several  
27  
28

1 different U.S.-run detention centers. The Special Rapporteurs requested a  
2 response by January 14, 2006. *Id.* at paras. 22-23.

3 iv. **Yemen** - On November 17, 2005, in a letter to the government of Yemen, the two  
4 Special Rapporteurs called to the government's attention information they had  
5 received concerning Mr. Bashmilah's transfer from U.S. custody to detention in  
6 Yemen. The Special Rapporteurs posed "specific questions concerning the  
7 legislation in Yemen referring to 'terrorism', and about the legal basis for the  
8 detention procedures to ensure that detainees had recourse to judicial review of the  
9 lawfulness of their detention." The Special Rapporteurs requested a response by  
10 January 14, 2006. *Id.* at paras. 28-30.

11  
12 15. The Special Rapporteur on Torture and Other Cruel, Inhuman or Degrading Treatment or  
13 Punishment published a report dated March 21, 2006 that referenced a letter he received  
14 from the government of Yemen in response to the communication outlined above in para.  
15 14(iv). This letter, dated December 20, 2005, explained that Mr. Bashmilah had been  
16 transferred to the custody of the government of Yemen by the U.S. government. Special  
17 Rapporteur Nowak's summary of the letter explains that the government of Yemen stated  
18 that Mr. Bashmilah was "not arrested but rather [was] handed over to them by the United  
19 States authorities" after having been accused of being a member of Al-Qaeda." The report  
20 further states that the letter explained that "The Yemeni authorities detained [him] under  
21 the Code of Criminal Procedures with a view to questioning [him] and verifying the  
22 allegations made by the US authorities. The Yemeni authorities received the files on [Mr.  
23 Bashmilah and another detainee] from the US authorities on 10 November 2005, and the  
24 legal procedures are being completed pending their arraignment before the courts."  
25 Attached hereto as Exhibit N is a true and correct copy of the Report of the Special

1 Rapporteur on Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment,  
2 Manfred Nowak, Addendum, Summary of information, including individual cases,  
3 transmitted to Governments and replies received (letter summarized at 340-341). *See also*  
4 attached hereto as Exhibit O a true and correct copy of relevant excerpts from the Report  
5 of the Special Rapporteur on the Promotion and Protection of Human Rights and  
6 Fundamental Freedoms while Countering Terrorism, Addendum, Communications with  
7 Governments (2007) (summarizing the same letter at para. 75).  
8

9 16. On January 5, 2007, the Special Rapporteur on Torture and Other Cruel, Inhuman or  
10 Degrading Treatment or Punishment published a report concerning a mission to Jordan  
11 that he undertook from June 25 to 29, 2006. Attached hereto as Exhibit P is a true and  
12 correct copy of the Report of the Special Rapporteur on Torture and Other Cruel, Inhuman  
13 or Degrading Treatment or Punishment, Manfred Nowak, Addendum, Mission to Jordan.  
14 In this report, the Special Rapporteur noted that Jordan “has repeatedly been mentioned in  
15 relation to the practice by the United States of America of ‘extraordinary renditions.’” *Id.*  
16 at para. 43. The Special Rapporteur stated that he had received “credible evidence”  
17 demonstrating that Mr. Bashmilah was held by the U.S. government in cooperation with  
18 the government of Jordan. *Id.* The Rapporteur included in his report a passage drawn  
19 from a letter he received from the government of Jordan dated January 18, 2006, in which  
20 the government confirmed that Mr. Bashmilah “was brought in to the [General  
21 Intelligence] Department for questioning on 21 October 2003.” *Id.* at n. 10. However, the  
22 government of Jordan refuted the allegations regarding Mr. Bashmilah’s detention; the  
23 Special Rapporteur summarized the government’s response on this point as follows:  
24 Jordan claimed that “the allegations are false as there is no record showing that Mr.  
25 Bashmilah and one other detainee] had been arrested for [. . .] violations of either the  
26

1 penal, disciplinary or administrative codes.” *Id.* Further, the Special Rapporteur  
2 explained that the government of Jordan stated that it did not possess any files indicating  
3 that Mr. Bashmilah posed a security threat.

4  
5 17. On March 15, 2007, the Special Rapporteur on the Promotion and Protection of Human  
6 Rights and Fundamental Freedoms while Countering Terrorism published a report that  
7 includes a summary of the same letter, written by the government of Jordan on January  
8 18, 2006, described in para. 16 above. Attached hereto as Exhibit Q is a true and correct  
9 copy of relevant excerpts from the Report of the Special Rapporteur on the Promotion and  
10 Protection of Human Rights and Fundamental Freedoms while Countering Terrorism,  
11 Addendum, Communications with Governments (2007) (letter summarized at para. 34).

12  
13 18. On March 22, 2007, in a *Note Verbale* to the United Nations Office of the High  
14 Commissioner for Human Rights, the Permanent Mission of Jordan to the United Nations  
15 Office at Geneva provided another response to allegations concerning the ill-treatment of  
16 Mr. Bashmilah. In this communication, the government of Jordan stated that Mr.  
17 Bashmilah “was brought back to the [General Intelligence] Department for questioning on  
18 21 October 2003... He was then told to leave the country, which he did on 26 October  
19 2003.” Attached hereto as Exhibit R is a true and correct copy of the *Note Verbale* from  
20 the Permanent Mission of Jordan to the United Nations Office of Geneva addressed to the  
21 Office of the High Commissioner for Human Rights.


22  
23 1. On November 30, 2005, the United Nations Working Group on Arbitrary Detention  
24 (“Working Group”) issued its Opinion No. 47/2005 concerning the detention of Mr.  
25 Bashmilah. Attached hereto as Exhibit S is a true and correct copy of the United  
26 Nations Working Group on Arbitrary Detention Opinion 47/2005.

1 19. This Opinion was issued while Mr. Bashmilah was still in custody in Yemen. The  
2 Working Group explained that the government of Yemen confirmed that Mr. Bashmilah  
3 was “handed over to Yemen by the United States...[t]he Government of Yemen add[ed]  
4 that the ‘competent authorities are still dealing with the case pending receipt of [the] files  
5 [concerning Mr. Bashmilah] from the United States of America authorities in order to  
6 transfer them to the Prosecutor.’” *Id.* at para. 15. In its Opinion, the Working Group  
7 made three important points concerning Mr. Bashmilah:  
8

- 9 i. The Working Group noted that Mr. Bashmilah’s transfers before he was returned  
10 to Yemen were accomplished “outside the confines of any legal procedure,”  
11 noting that he therefore was not given “access to counsel or to any judicial body  
12 to contest the transfers.” *Id.* at para. 19.  
13  
14 ii. The Working Group found that the Yemeni government detained Mr. Bashmilah  
15 without a legal basis and that the detention was therefore arbitrary. The Working  
16 Group opined that the government of Yemen was in violation of article 9 of the  
17 Universal Declaration of Human Rights and article 9 of the International  
18 Covenant on Civil and Political Rights, which both guarantee that no one shall  
19 be subject to arbitrary detention. *Id.* at para. 21.  
20  
21 iii. The Working Group requested that the government of Yemen either release Mr.  
22 Bashmilah or bring him before a competent judicial authority. *Id.* at para. 22.
